1.0 Terms of Tender and Tender Overview

1.1 Terms of Tender

- 1.1.1 The terms and conditions applicable to this Tender Process are detailed in Sections T1, T2, and T3, C1 to C7 may only be available with the complete Tender Document following payment of the Tender Fee.
- 1.1.2 SME Bidders will be exempted from Tender Fee and Tender Bond.

1.2 About Oman Broadband Company

- 1.2.1 Oman Broadband Company SAOC (Oman Broadband) founded in 2014 as a joint-stock company wholly owned by the government of the Sultanate of Oman. It is strategically vital to Oman future development serving wider digitization agenda of the Company.
- 1.2.2 Through its visionary and collaborative approach to the market, Oman Broadband will help to empower the nation with high-speed broadband fiber access to citizens and business alike.
- 1.2.3 The company aims to have the maximum nation coverage in line with the digital Oman strategy, e-Government and Oman Future Economic Vision.
- 1.2.4 The next generation fiber optic network will become exponentially faster, bringing community and enterprise benefits of enhanced delivery of communication services, cost savings, increased competitiveness and improved sustainability.
- 1.2.5 Oman Broadband focuses upon the development of a passive fiber network infrastructure, providing equal and open access to telecommunication service providers, on a wholesale basis, and owners and operators of private networks, on a retail basis, thereby enabling end users to efficiently leverage high speed fiber in Oman.

1.3 Description of the Service

- 1.3.1 Provide 7 housekeeping & hospitality service workers as a minimum and the company may as more workers up to or more workers during the period of the contract depending on the need of service for two years duration for the entities of Oman Broadband,ITHCA Group Company and Onsor.
- 1.3.2 Proposed hospitality service workers must be having speak basic English and have enough experience to serve VIP gusts.
- 1.3.3 Proposed hospitality service workers must be having experience in making hot beverages especially Omani Coffee and Karak tea.
- 1.3.4 Provide uniforms with all the company's logo for proposed personnel.
- 1.3.5 Routine internal cleaning & housekeeping of all office areas.
- 1.3.6 External cleaning of all head office areas as appropriate.
- 1.3.7 Internal intensive cleaning as appropriate once a week.
- 1.3.8 Provide pest control service as appropriate.
- 1.3.9 Provide deep cleaning and carpet shampooing.
- 1.3.10 Provide furniture movement (assembling & disassembling).
- 1.3.11 Garbage collection and disposal to pick up points.
- 1.3.12 Assisting in photocopying & faxing, binding, mail distribution services...etc.
- 1.3.13 Supply and maintain stock cleaning materials/ equipment.
- 1.3.14 Provided all the required cleaning materials
- 1.3.15 Service shall be provided during any emergency occurring at any time.
- 1.3.16 Miscellaneous housekeeping works.



1.4 Minimum Requirements to Participate in Tender

1.4.1 Technical Requirements

2.0 Requirements to Collect Tender Document

2.2 Tender Fee

- 2.2.2 SME Bidders will be exempted from Tender Fee and Tender Bond. However, SME Bidder must submit Riyada Card.

2.3 Confidentiality Declaration

The Confidentiality Declaration must be completed, signed by an authorized person, stamped with the Bidders company stamp, and be presented, by hand or scanned and forwarded via email, to the Oman Broadband Contracting Section before the Tender Documents can be released to the Bidder.

3.0 Oman Broadband Contact Point

- 3.1.2 No Clarification Requests shall be entertained after the Clarification Request Closing Date included in the table in Article 7.0 below.



4.0 Bid Bond

4.1.1 To ensure conformance of the Tender, the Oman Broadband requires the Bidder to issue a Bid Bond in the exact format detailed in Section T3. The value of this Bid Bond shall be indicated in Section T3. The Bid Bond shall be forwarded to Oman Broadband as a separate envelop along the tender proposal. The Bid Bond shall be enforced in the event that Bidder fails to submit and substantiate a conforming bid or has failed to accept the award of the contract or purchase order.

11.1 Definitions

11.1.1 Confidential Information

Shall mean all knowledge, data or information acquired by Bidder from, or disclosed to Bidder by the Oman Broadband, or on behalf of Oman Broadband, in connection with the Tender Documents, Clarifications and the Tender Process in writing, drawings, computer programs or in any other way, as well as all knowledge, data or information derived there from, to the extent that such knowledge, data or information at the time of such acquisition or disclosure is not either already in the unrestricted possession of Bidder or part of public knowledge or literature.

11.1.2 Confidential Record

Shall mean all Tender Documents, Clarifications and any other material containing Confidential Information.

11.1.3 Third Party

Shall mean any party other than Oman Broadband or Bidder.

11.2 Confidentiality

- 11.2.1 Bidder shall preserve and cause its employees to preserve the confidentiality of any Confidential Information.
- 11.2.2 Bidder shall not for any purpose other than the preparation and submission of a Bid:
 - a) disclose to any Third Party or enable any Third Party to note the fact that Bidder has been invited to submit a Bid and/or, if applicable, the fact that the Contract is awarded to Bidder.
 - b) reproduce, copy or use, or disclose to, place at the disposal of or use on behalf of any Third Party or enable any Third Party to read, copy or use, any Confidential Information; except with the prior written consent of Oman Broadband.
- 11.2.3 The undertakings above shall continue insofar and for so long as the Confidential Information or Confidential Record in question has not:
 - c) become part of the public knowledge of literature otherwise than through any act or default on the part of Bidder; or
 - d) been disclosed to Bidder under an obligation to maintain secrecy by a Third Party (other than one disclosing on behalf of Oman Broadband) who could lawfully do so and who did not derive such Confidential Information or Confidential Record from Oman Broadband.

11.3 Copyright

11.3.1 The copyright in any Confidential Record shall, in the absence of any express provision to the contrary thereon, be vested in Oman Broadband. Copyright in any record containing geological or geophysical data acquired or generated by Bidder in connection with the Contract shall be vested in Oman Broadband.
